Several weeks later, police \_\_\_\_\_ and arrested Dennis Anderson, who was accused of the hit and \_\_\_\_\_ against Ann Miller. On Friday he was sentenced to seven \_\_\_\_\_ in state prison, with 297 days of \_\_\_\_\_ served in the Lincoln County Jail, plus \$155 in fines and fees. On a careless-driving charge, Anderson was \_\_\_\_\_ \$200 plus \$39 in fees. Anderson was also ordered to reimburse the state victims fund \$5,000 and \_\_\_\_\_ the victim's \_\_\_\_\_ more than \$13,000 in funeral and burial \_\_\_\_\_. The application that was filed, on behalf of Anderson, to the state's early release Intensive Supervision Program was denied.
